- _____ **Option 1:** I will **not** use FACTS during the 2010-2011 school year. I will prepay the full amount due on or before July 20, 2010. A discount of 3% will be applied. Payment will be made directly to SFCCS. No FACTS fee will be assessed.
- _____ **Option 2:** I will **not** use FACTS during the 2010-2011 school year. I will make two equal payments. The first payment due July 20, 2010 and second payment due December 15, 2010.
- _____ **Option 3:** I **will** use FACTS to make eleven monthly payments beginning July 2010 and ending May 2011. The non-refundable enrollment fee for using FACTS is \$41.00. I elect to pay on the (circle one) 5th / 20th of the month. There will be a \$25.00 late fee assessed by FACTS in the event funds are not available on the specified date. Your 2009-2010 FACTS account must be current in order to reenroll.

Credit Card Payments

New for SFCCS this year, families can choose to pay by credit card using Master Card, American Express or Discover with Options 1, 2, or 3. Families choosing to pay by credit card will be assessed a 2.5% fee (added to the total amount of the tuition agreement).

Should you be approved for financial assistance, the amount approved will be credited to your tuition. Monthly payments will be adjusted accordingly, if applicable.

**If you are a returning Catholic Family, your Participating Parishioner Card must be on file in order to obtain the Catholic rate. If not, the Non-Participating rate will be applied until the card is received.

IF YOU ARE NEW TO ST. FRANCES CABRINI AND/OR CHOOSE OPTION 3, PLEASE ASK FOR INFORMATION ON ENROLLMENT FOR THE FACTS TUITION MANAGEMENT PROGRAM. THE AGREEMENT IS **NOT NEEDED IF YOU ARE CURRENTLY USING FACTS**. CURRENT FAMILIES USING FACTS WILL BE AUTOMATICALLY RE-ENROLLED AND CHARGED THE NON-REFUNDABLE \$41\$ FEE.
